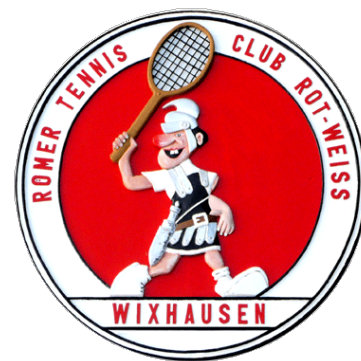


Membership Application Form

Bank account, where the annual fee and other financial obligations can be deducted, when due for payment:

SEPA- Direct Debit Mandate: I authorize the RTW (Creditor-Identifier: DE15 RTW 00000 238222) to deduct payments from my bank account via direct debit. Simultaneously I herewith instruct my credit institute to cash the direct debits drawn from the RTW. In cases where these planned direct debits were announced in time and could not be cashed, I shall be liable for the additional costs incurred.
